Before an annulment action can be filed in Pennsylvania, one or both of the spouses must have resided in Pennsylvania for at least six months. In certain circumstances, an action for annulment can be brought by parents if their child was under age 18 and their consent was not obtained for the marriage or if their child lacks mental capacity.

Basics of Annulment in Pennsylvania: Some Important Considerations There are distinct differences between a divorce and an annulment. An annulment refers to a Court Order declaring that a marriage is void. In other words, an annulment is a declaration that the marriage never legally existed.

**Grounds For Annulment in PA: Does Your Marriage Qualify ...**

Either party can file for annulment under 23 Pa.C.S. § 3303, whether the marriage is “void” or “voidable.” The process for filing simply requires submitting a request with your local courthouse to annul the marriage.

**Steps to Getting an Annulment in Pennsylvania**

While most marriages end with the death of one partner or a divorce, one other legal way exists for Pennsylvania residents to dissolve their marital relationship. annulment of marriage in PA is a way to end a marriage that differs from divorce in a few key ways.

**Annulment of Marriage in Pennsylvania — Marriage — LAWS.com**

An annulment in Pennsylvania is what the legal community refers to as a “legal fiction”. The legal result of an annulment is, very technically, that the marriage never really happened.

**Annulment in Pennsylvania — Davis Divorce Law**

A civil annulment in PA includes two main categories: void marriages and voidable marriages. Each addresses different grounds for annulment. Your marriage must fall under one of those grounds in order to qualify for an annulment. Note that a civil annulment is different from a religious annulment.

**Rules for Annulment in Pennsylvania | Law for Families**

Most of the grounds for annulment in Pennsylvania are there to end marriages that should never have begun in the first place. This includes marriages that legally should not have occurred, as well as marriages that people would generally reconsider.

**Grounds for Annulment in Pennsylvania**

The regulation of marriage happens at the state level, with laws prohibiting certain types of marriage and determining when a marriage may be annulled (or invalidated). Under Pennsylvania annulment and prohibited marriage laws, grounds for annulment include the presence of an undissolved previous marriage and mental incompetence, among others.

**Pennsylvania Annulment and Prohibited Marriage Laws — FindLaw**

An annulment is legal decree that states that a marriage was never valid. The legal effect of an annulment is to void the marriage as though it never existed. Generally, the length of time married is not a determining factor to request an annulment. Mere regret alone is generally insufficient grounds for an annulment.

This question is asked by the previously married Petitioner who wants to know whether he or she is now free to enter a future valid marriage in the Catholic Church. If the tribunal, following a complete investigation of the facts, finds that a previous marriage was invalid, a Decree of Nullity is issued, termed in common speech an “annulment”

**The Tribunal, Marriage Annulments, Church Court, Remarriage:**

If an Annulment is Granted the Children will be Illegitimate Truth: The truth is that an ecclesiastical annulment is concerned only with the spouses, and not the children. An annulment has no effect at all on the legitimacy of children, or other arrangements regarding children, such as custody or support.

There are two categories of marriages that provide grounds for annulment in Pennsylvania. First, there are marriages that are considered void by their existence. Second, there are marriages that are voidable upon action of either party. The difference with voidable marriages is they are considered valid until either party takes action.
